## 2020 ROOSTER RUN RECAP

The Inaugural Rooster Run is now in the books and it seems that despite a few minor things that need to be tweaked moving forward, it was a huge success. The young hunters swarmed our 160 acre complex under the guidance and supervision of our experienced safety driven event staff, with the goal of harvesting a ring-necked pheasant. We hope to share our legacy again, with another group of youngsters in 2021.
